

**NAVAJO COUNTY BOARD OF SUPERVISORS MINUTES**  
**MONDAY, December 18, 2006**

**9:03 a.m. CALL TO ORDER:** Supervisor Thompson led the Pledge of allegiance and offered the invocation.

**PRESENT:** Jesse Thompson, Chairman; Percy Deal, Vice-Chairman; J.R. DeSpain, Member; David Tenney, Member; Jerry Brownlow, Member; Mel Bowers, County Attorney; James G. Jayne, County Manager, and Darlene Fraley, Clerk of the Board.

**CALL TO THE PUBLIC:** There was no response.

**CONSENT AGENDA:** a) Voucher list for payment; b) Minutes—October 16 and 23, 2006; November 20, 2006; c) Intergovernmental agreement for election services between Navajo County and the City of Holbrook; d) Warrants over \$1,000—August through November 2006; e) Letter of support for proposed oriented strand board plant in the Winslow area: **Supervisor DeSpain made a motion** to approve the Consent Agenda items and authorize the Chairman to sign them; motion seconded by Supervisor Tenney; vote unanimous approving the motion.

**INDUCTION TO OFFICE CEREMONY FOR ELECTED OFFICIALS:** The Honorable Dale Nielson, Presiding Judge, administered the Oath of Office to the recently elected officials: Superintendent of School Linda Morrow; Clerk of the Superior Court Juanita Mann; Justices of the Peace Ralph Hatch, Alison Kolomitz, Fred Peterson, Evelyne Bradley, Steve Price and David Widmaier; Constables Madeline Pauline Hernandez, Ray Brown and Ryan Reinhold. Juanita Mann thanked everyone present, expressing appreciation to the board, elected officials, and county residents for her re-election. Chairman Thompson recognized retiring Judge Bradley who thanked the board, Judge Kolomitz, and Judge Petersen, stating she had enjoyed working with them for the last eight years. Judge Bradley introduced her family members that were present. Supervisor Deal thanked Honorable Judge Bradley for her service on the Navajo Reservation. Treasurer Manny Hernandez introduced the new constable Pauline Hernandez. All Supervisors congratulated the newly elected officials.

The board took a short recess beginning at 9:30 a.m. and reconvened at 9:46 a.m.

**CONSTABLES:** Consideration and possible approval to establish a writ fee for all writs issued by Justice Courts pursuant to ARS §22-136 (F) and §11-445 (A) (17): Constable Ryan Reinhold discussed the implementation of the statute that allows writ fees to be charged, stating revenue generated by these fees can be used to offset charges for mandated constable training and the Constable Ethics Committee. He requested that a public hearing be set for January 16<sup>th</sup> to consider adopting a \$5.00 fee for each writ issued and direction was given to staff to schedule this hearing.

**PETRIFIED FOREST NATIONAL PARK:** Consideration and possible approval of letter of support to establish the Petrified Forest National Park as a World Heritage Property: Superintendent Lee Baiza of the Petrified Forest National Park discussed the intent of the Park to nominate that entity to be designated as a World Heritage Property. He discussed the history of the program as being introduced in 1973 to present the day when there are 812 sites world wide. He reported there are 20 national parks designated World Heritage sites and that this program promotes these sites internationally to benefit academia, research, and preservation of the site. Supervisor DeSpain thanked Mr. Baiza for providing this information and for his service at the park and intensely promoting it. **Supervisor DeSpain made a motion** to approve a letter of support to nominate the Petrified Forest National Park as a World Heritage Property; motion seconded by Supervisor Brownlow. Supervisor Deal inquired why only the 93,000 original acres were included and Mr. Baiza stated that only 160 acres of the additional authorized lands have been acquired. In response to a question from Supervisor Deal regarding whether letters of support had been obtained from the Navajo Nation, Mr. Baiza reported he did not yet have a letter of support and listed the agencies who have already offered support. Chairman Thompson requested that informational booklets be provided to the schools regarding the Petrified Forest. Mel Bowers inquired how many research projects are going on at the Park and Mr. Baiza stated that they constantly get applications from researchers who want to conduct research within the park and

they have become very selective of approving research projects. He advised there are currently 18 research projects, most of them university based, and listed some projects that are ongoing, discussing the research benefits that would come to the park if there is world wide exposure. He discussed school projects educating children on the park. Motion carried unanimously.

**CHARACTER FIRST PRESENTATION:** James G. Jayne and Shalice Cook discussed the Character First program, providing information that this is an internationally known program that has been implemented in schools, cities, and businesses. Mr. Jayne advised that Kent Fahrenbruck had conducted a two day training of several staff members and had also presented a brief overview of the program to department directors and elected officials. He said he anticipates intensive training of key personnel in the county. Shalice Cook advised the program positively impacts the work environment through the reinforcement of 49 character qualities, discussing how this program can benefit the County by: helping to address workforce challenges such as absenteeism, low productivity, and quality problems; improving working relationships; and facilitating better communication. She specifically addressed the quality of sensitivity, the December character trait. Ms. Cook discussed ways that the future training will be implemented in the county. Mel Bowers stated that in the presentation he attended it struck him that by teaching these qualities you develop a common language in the office environment. He stated he was favorably impressed with the program. Supervisor Tenney stated that he would like to see questions on job interviews developed around these character traits. The audience viewed a video of the December character trait Sensitivity.

**HUMAN RESOURCES: Consideration and possible approval of Personnel Actions:** Gail Calisen reviewed the Personnel Action items. **Supervisor Tenney made a motion** to approve the Personnel Actions as presented and authorize the Chairman to sign the actions; motion seconded by Supervisor Brownlow; vote unanimous approving the motion with Supervisor DeSpain absent for the vote.

**ASSESSOR: Consideration and possible approval of Intergovernmental Agreement with the Arizona Department of Revenue for Data Processing Products and Services from July 1, 2006 through June 30, 2007:** This item was continued to a future meeting.

**NAVAJO COUNTY SCHOOL SUPERINTENDENT: Consideration and possible approval to declare the appointment of Mae Bigboy to the Cedar Unified School District #25 Governing Board void due to a misunderstanding regarding the residency requirement to hold that position; declare position vacant; and give notice to the Navajo County School Superintendent so that vacancy can be filled:** Superintendent Linda Morrow advised that Mel Bowers had met with Mae Bigboy who indicated she does not live within the boundaries which makes her ineligible to serve. **Supervisor Tenney made a motion** to declare the appointment of Mae Bigboy to the Cedar Unified School District #25 Governing Board void due to a misunderstanding regarding the residency requirement to hold that position; motion seconded by Supervisor Deal; vote unanimous approving the motion with Supervisor DeSpain absent for the vote.

**NAVAJO COUNTY PUBLIC HEALTH SERVICES DISTRICT: Board of Directors Session: Supervisor Tenney made a motion** to enter into the Navajo County Public Health Services District **Board of Directors' Session**; motion seconded by Supervisor Brownlow; vote unanimous approving the motion with Supervisor DeSpain absent for the vote.

- a. **Consideration and possible approval of Amendment #2 of Contract #HG561143 with the Arizona Department of Health Services for the Dental Sealant Program effective 1/1/2007 to 9/30/2009:** Mary Tyler reviewed this amendment, stating the contract was revised to raise the reimbursement fee for dental sealant by \$5.00 and to provide reimbursement for training costs. **Supervisor Tenney made a motion** to approve Amendment #2 of Contract #HG561143 with the Arizona Department of Health Services for the Dental Sealant Program effective 1/1/2007 to 9/30/2009; motion seconded by Supervisor Brownlow; vote unanimous approving the motion with

Supervisor DeSpain absent for the vote.

- b. Consideration and possible approval of new contract with Debra Smalley, Registered Nurse Practitioner, to provide family planning services to Navajo County residents: After review of the contract, **Supervisor Tenney made a motion** to approve a new contract with Debra Smalley, Registered Nurse Practitioner, to provide family planning services to Navajo County residents; motion seconded by Supervisor Brownlow. Supervisor Deal inquired if Debra Smalley is a Navajo County resident and was advised she is. Vote unanimous approving the motion with Supervisor DeSpain absent for the vote.
- c. Consideration and possible approval of Contract #HG361315, Amendment #5 for Family Planning Services with the Arizona Department of Health including scope of work and new price sheet: Mary Tyler reviewed this contract amendment. **Supervisor Tenney made a motion** to approve Contract #HG361315, Amendment #5 for Family Planning Services with the Arizona Department of Health including the scope of work and new price sheet; motion seconded by Supervisor Brownlow; vote unanimous approving the motion with Supervisor DeSpain absent for the vote.
- d. Consideration and possible approval of contract with Midwest Cancer Screening for period January 1, 2007 through December 31, 2007: **Supervisor Tenney made a motion** to approve the contract with Midwest Cancer Screening for period January 1, 2007 through December 31, 2007; motion seconded by Supervisor Brownlow; vote unanimous approving the motion with Supervisor DeSpain absent for the vote.

**Supervisor Tenney made a motion** to return to regular session; motion seconded by Supervisor Brownlow; vote unanimous approving the motion with Supervisor DeSpain absent for the vote.

#### **ELECTION SERVICES:**

- a. Consideration and possible approval for Navajo County Election Services to conduct the March 13, 2007 precinct-based Primary Election for the City of Holbrook: Kelly Dastrup advised that this will be a primary election. **Supervisor Tenney made a motion** to authorize Navajo County Election Services to conduct the March 13, 2007 precinct-based Primary Election for the City of Holbrook; motion seconded by Supervisor Brownlow; vote unanimous approving the motion with Supervisor DeSpain absent for the vote.
- b. Consideration and possible approval for Navajo County Election Services to conduct the Show Low Unified School District Override Election March 13, 2007 with approval of polling places as presented: Kelly Dastrup advised this election will be for a maintenance override election and there are polling place changes that will require Department of Justice approval that include moving from the unused Pinedale Elementary school into the Pinedale fire station. **Supervisor Tenney made a motion** to authorize the Navajo County Election Services to conduct the Show Low Unified School District Override Election March 13, 2007 with approval of polling places as presented; motion seconded by Supervisor Brownlow; vote unanimous approving the motion with Supervisor DeSpain absent for the vote. Supervisor Tenney thanked Kelly Dastrup for her assistance in this election process and encouraged everyone to get out and vote.

**FINANCE:** Consideration and possible authorization for Finance/Purchasing to award a professional services contract to Tomhave Group: Chairman Thompson advised that they had met with the Tomhave group while in Washington D.C. and found them to be very aware of Native American issues. Mary Jane Springer stated that three firms provided proposals and Tomhave appears to be the most qualified. Supervisor Tenney and James Jayne stated that they were impressed with what this group will be able to do for all of Navajo County. Supervisor Deal stated that he is concerned that it is difficult to evaluate a group's performance in six months and would feel more comfortable with a 12 month period. He advised there will be a new Congress and it may difficult for the group to obtain results in such a short time frame. Mr. Jayne stated that the budget was adopted for this fiscal year and they did not want to commit the Board of Supervisors beyond this fiscal year. He said the board could then make a policy decision in the budget process. Concern was expressed that care must be taken to assure that there is no conflict of interest with the Navajo Nation. Mr. Jayne stated that in conversation with this group he has found them to be very communicative on dealing with sensitive issues. **Supervisor Brownlow made a motion** to approve the professional contract with the Tomhave Group; motion seconded by Supervisor Tenney; vote unanimous approving

the motion.

**WHITE MOUNTAIN LAKE RECREATION DISTRICT: BOARD OF DIRECTORS' SESSION:**

Consideration and possible approval of appointment of Don Anderson-Cosgrove as a member of the White Mountain Lake Recreation District Advisory Committee: **Supervisor Tenney made a motion** to enter into a **White Mountain Lake Recreation District: Board of Directors' Session;** motion seconded by Supervisor DeSpain; vote unanimous approving the motion. John Hager advised that Mr. Anderson-Cosgrove is a new resident of the district, his wife participates on the Home Owners' Association and they will bring a new perspective to the committee. Supervisor DeSpain expressed appreciation for John Hager's service to this district. **Supervisor DeSpain made a motion** to approve the appointment of Don Anderson-Cosgrove as a member of the White Mountain Lake Recreation District Advisory Committee; motion seconded by Supervisor Tenney. Mr. Jayne stated he met with Mr. Anderson-Cosgrove and found him to be very interested in serving the county in this way as well as other entities in the county. Vote unanimous approving the motion with Supervisor Deal absent for the vote. **Supervisor Tenney made a motion** to return to regular session; motion seconded by Supervisor DeSpain; vote unanimous approving the motion.

**PUBLIC WORKS/PLANNING & ZONING:**

- a. **PUBLIC HEARING** to consider action on a zone change request by Roger Owens for parcel 206-21-041E in the Heber Overgaard area: Chairman Thompson stated he understood this item has been withdrawn and invited public comment and there was none. Chairman Thompson stated this item would be continued until further notice.
- b. **PUBLIC HEARING** to consider the adoption of the Planning and Zoning Review fees: Dusty Parsons advised they have received letters of support for these fees and have received no letters of opposition. He stated these fees will help them recoup hard costs. Chairman Thompson invited public comments and there were none. **Supervisor Tenney made a motion** to adopt the Planning and Zoning Review fees, thanking staff for their work on this; motion seconded by Supervisor Brownlow who stated he had received comments in his district that fees are part of doing business. Vote unanimous approving the motion.
- c. **Consideration and possible approval to award a sole source contract not to exceed \$65,000 to Brimhall Hardluck Quarry for the hauling of millings to various locations within District II:** Dusty Parsons advised Lance Payette believed this could be a sole source award because this entity is currently working in that area and could significantly reduce costs by being in that area. Chairman Thompson requested board support stating the roads in the District II area need the application of these materials. **Chairman Thompson made a motion** to approve a sole source contract not to exceed \$65,000 to Brimhall Hardluck Quarry for the hauling of millings to various locations within District II; motion seconded by Supervisor Tenney; vote unanimous approving the motion.
- d. **Consideration and possible approval of Task Agreement # Three (3) for Memorandum of Agreement CTH65T60880 the BIA, Hopi Agency, Western Region and Navajo County:** Dusty Parsons introduced Clarence Begay of the BIA who discussed an accident on 264 where they totaled their dump truck. He said they are requesting assistance in purchasing a used dump truck from Navajo County Highway Division. Supervisor Deal stated he feels there is a good relationship established with the Hopi Tribe, County and Hopi BIA in the name of cooperation, understanding, and supporting each other when the need arises. He further stated that over the months and years whether the Hopi tribe or BIA placed an item on the agenda requesting financial support he never hesitated to give that support, particularly as related to roads. He said he always expected the same to be returned but that has not been the case. He said he requested the BIA and Hopi Tribe repair a damaged road that has been damaged for a couple of years, which was made worse during recent rain storms so it is now totally destroyed. He requested the same level of understanding and support from the Hopi BIA and Hopi Tribe as they have experienced from this board as this can not be a one-way street. Supervisor Deal expressed support for this action. Chairman Thompson stated that they talked about Supervisor Deal's request at a recent task force meeting and they will meet with Supervisor Deal and Bureau of Indian Affairs' officials. Mr. Begay stated that there is a meeting scheduled for January 8, 2007, in Kykotsmovi involving regional officials from both the

Navajo and Western Region to discuss the questions. He said he is in support of the repair that needs to be done and is unsure why it is taking so long; he will look into it and try to make this happen. Supervisor DeSpain discussed the cost differential, stating he understood we had to do some work on the equipment. Mr. Parsons stated that this vehicle, when purchased, had an experimental engine and it was part of the contract to replace that engine. Supervisor DeSpain inquired if the vehicle is in good condition and was told that it is. **Supervisor Tenney made a motion** to approve Task Agreement # Three (3) for Memorandum of Agreement CTH65T60880 the BIA, Hopi Agency, Western Region and Navajo County; motion seconded by Supervisor Brownlow; vote unanimous approving the motion.

- e. Consideration and possible approval to award the purchase of a second dump truck under contract #B06-08-030: Dusty Parsons reported that receiving the \$50,000 from District II for the previous item will enable them to make a new purchase on this contract. **Supervisor Tenney made a motion** to approve the purchase of a second dump truck under contract #B06-08-030; motion seconded by Supervisor DeSpain; vote unanimous approving the motion.

**BOARD BUSINESS:** All Supervisors, James Jayne and Mel Bowers wished everyone present a Happy Holiday. Supervisors reported on activities within their district, meetings they had attended and issues related to constituents in their districts. Mr. Jayne thanked Mr. Tenney for his service on the Show Low School District Governing Board, which is ending this month. He also announced Ryan Patterson is leaving the county as he accepted a position at NPC and that Legal Defender Ben Cole will retire at the end of January. Mel Bowers discussed the contributing factors to trying over 1300 felony cases last year, which is significantly higher than usual. He invited Supervisors and the County Manager to attend drug court, making arrangements with him in advance. In response to a question from Supervisor Deal, Mr. Bowers stated they do not have jurisdiction over the reservation but they do have some Native Americans in the Drug Court program off the reservation.

**ADJOURN:** At 11:50 a.m., **Supervisor Deal made a motion** to adjourn; motion seconded by Supervisor Tenney; vote unanimous approving the motion.
