9:00 a.m. Call to Order: Pledge of Allegiance and Invocation were led by Supervisor Tenney.

**CALL TO THE PUBLIC:** There was no answer to the call to the public.

Vote unanimous approving the motion. Mr. Jayne thanked Mr. Vela for his representation of Navajo County.

He further reported on the 3<sup>rd</sup> Annual Drug Summit. Supervisor DeSpain thanked everyone for coming out to the 78<sup>th</sup> Annual Navajo County Fair.
