9:03 a.m. Call To Order: Pledge of Allegiance and Invocation led by Supervisor Whitesinger.

Supervisor Whitesinger made a motion to approve to accept 0.61 miles of Broadway Drive, East of the intersection Highland Road and Broadway Drive, into Navajo County Roadway Maintenance System; motion seconded by Supervisor Allen. Vote unanimous approving the motion.

JUVENILE PROBATION/COUNTY ATTORNEY: Consideration and possible acceptance of the award for the Drug Free Communities Grant Proposal submitted by the Navajo County Drug Project. Navajo County is proposed to be the fiscal agent for the Drug Free Communities Grant. The new positions will be a part of the Navajo County Attorney's Office who will administer the grant. Arno Hall discussed the item. Supervisor Allen inquired about the status of Navajo County's drug problem. Mr. Hall reported he believes that we are doing a good job educating citizens. County Attorney Brad Carlyon offered up some information regarding the new kinds of drug coming out. Supervisor Allen indicated she would like to see the Health Department educate young mothers regarding the effects of their drug use upon their newborn babies. Supervisor Allen made a motion to approve the award for the Drug Free Communities Grant Proposal submitted by the Navajo County Drug Project Navajo County is proposed to be the fiscal agent for the Drug Free Communities Grant. The new positions will be a part of the Navajo County Attorney's Office who will administer the grant; motion seconded by Supervisor Whitesinger. Vote unanimous approving the motion.

COUNTY BUSINESS UPDATE: Report from Board members, County Attorney and County Manager: James Jayne, County Manager reported on his son's wrestling tournament. Brad Carlyon, County Attorney spoke about the AACo conference and the Veterans Court. Supervisor Allen spoke about the Summit Health tour and the Mexican Wolf meeting with included many forest service representatives. Supervisor Whitesinger spoke about the McNary Library, the Sunrise Ski Resort and meetings with the Whiteriver Tribal Council. She further thanked Chief Wheeler from Pinetop-Lakeside who hosted a Young Leadership Group that Supervisor Whitesinger is currently working with. She further spoke of the safe house that the Youth Leadership Group volunteered at. She indicated she had a follow up meeting with the BIA. Supervisor Tenney spoke of the Summit Healthcare tour, the AACo conference and he reported on Supervisor Allen's comments at the Wolf Hearing at Hon-Dah. He reported that he and Hunter Moore met with Senator Flake and Senator McCain. Supervisor Thompson reported on the Summit Health tour and the NACOG Economic Development meeting. Supervisor Thompson reported on the new Hopi Chairman Herman G. Honanie and Vice-Chairman Alfred Lomahquahu. Chairman Nez reported on his family events and thanked everyone for their support. Chairman Nez thanked the Personnel Commission for the Navajo County Christmas Party.
