

Downloading Plat Maps

Plat maps can be downloaded from the public website under the Assessor's department. To begin, navigate to the Assessment Information page.

1. Navigate to the "Assessment Information" page. Opening that page can either be done from the "Quick Links" section of the main page or using the side box on a subpage.
