ATTEND DEFENSIVE DRIVING CLASS (DDC)

You are eligible for the Defensive Driving Class if:

- You have not attended within the last 12 months (violation date to violation date); and
- You **do not** contest your ticket; and
- You were cited for a moving civil violation not involving serious injury or death; and
- An asterisk (*) is listed next to the violation on page 5; and

INSTRUCTIONS FOR ATTENDING DEFENSIVE DRIVING CLASS (DDC)

- If you choose to attend this course, you must:
- Complete the course at least seven (7) days prior to your court date. Your court date is located at the bottom right of your ticket. If you default (fail to attend DDC before the court date) you are no longer eligible for defensive driving class.
- You may only attend an Arizona Supreme Court certified school. For a list of available schools, call **888-334-5565** or visit the website: www.azcourts.gov
You cannot attend an out-of-state school: you **must** register with an Arizona school.
- Have your ticket and a pen or pencil with you when you call to schedule a class. You will need to write down instructions for attendance as well as give important information on your ticket to the person registering you.
- Please locate the following information on your ticket before you call.
 - ✓ Driver's license number
 - ✓ Court Date
 - ✓ Complaint Number (located in upper left hand corner of your ticket)
 - ✓ The section your violation appears in (A, B, C, D, E).
 - ✓ Violation Code
 - ✓ Violation Date
- Take your driver's license, traffic ticket and money order with you on the day of the class. Cash and personal checks **are not** accepted at the class.

- Payment in full must be **received or postmarked** before your court date, or extra fees must be added.
- If you are late in a civil traffic violation, a \$20 late fee and a \$30 default fee must be added. If your citation was issued by the Show Low Police Department, a \$10 late fee must also be added.
- If you are unable to pay the amount in full, you must appear or submit a written request to arrange a payment schedule prior to your court date. A time-payment fee of not more than \$30 must be added.

We must receive your request for a hearing **before** the court date shown at the bottom right of your ticket. You will then be notified by mail of your trial date. **Setting a hearing will result in the loss of the privilege to attend defensive driving class for violation dismissal. Failure to appear at your scheduled hearing date will result in default judgment entered against you for the amount of the fine plus collection costs and fees.**

NOTICE TO JUVENILES

1) Juveniles charged with civil traffic violation(s) only, may choose any option on page one. 2) Juveniles charged with criminal traffic violation or misdemeanor offenses must appear in court in person with a parent/guardian; 3) Juveniles who admit to, or are found responsible for, a moving traffic violation are subject to separate administrative action by the Motor Vehicle Division which may include attendance at traffic survival school (TSS) or suspension of driving privileges

If you are required to pay fines, penalties, fees or other financial obligations as a result of a judgment of this court and you are unable to pay, bring this information to the attention of the court staff or the judge because payments over time or other alternatives may be available. Do not ignore your responsibility to pay, as this may result in additional penalties and costs to you. For more information, contact the court or an attorney.

Fine Schedule

Violations marked with a single asterisk (*) are eligible for the Defensive Driving Class. You may not be eligible if you have a commercial driver's license.

****28-2532A VEHICLE REGISTRATION:** (a) No fine if your registration is valid, show proof to the court; or (b) \$646.00 if registration not renewed; or (c) No fine if the defendant was an operator but not the owner of the motor vehicle, trailer or semitrailer. Show proof to the court.

28-3473 SUSPENDED DRIVER LICENSE If you are charged with any violation of 28-3473, you should contact the Motor Vehicle Division to find out how to reinstate your license. By following MVD's procedures, your sentence may be reduced or the violation dismissed. If you are charged with 28-3473, you must:

- 1) Contact MVD to determine which Court has your unpaid tickets.
- 2) Pay tickets in full.
- 3) Take proof of payments to MVD.
- 4) Pay reinstatement fee to MVD.
- 5) **Bring proof of reinstatement (including valid driver license) to this Court on your court date. *SEE JUDGE****

****** 28-4135A-C VEHICLE INSURANCE:** (a) No fine with proof shown to court that your insurance was valid ON DATE AND TIME COMPLAINT WAS ISSUED; (b) \$241.00 with proof of six-month insurance policy AND 36-month MVD Driver Record showing no prior violations in the last 24 months or not more than violation in the last 36 months. You can obtain your driver record you're your local MVD office or online: www.azmvdnow.gov. If you have prior violations, MVD may suspend your vehicle registration and/or driving privileges for 90 days. (c) \$1100.00 and a **three-month suspension of driving privileges & vehicle registration** if no proof of insurance shown.

*******28-4139A SUSPENDED REGISTRATION PLATE:** (a) \$375.00 if reinstated vehicle registration and MVD receipt shown to court; or (b) \$656.00 if registration not reinstated; or (c) violation may be dismissed if you show proof from MVD that suspension was an MVD error.

+ 28-3169A, 28-2158 LICENSE OR REGISTRATION NOT IN POSSESSION: (a) Charge will be dismissed with proof of driver license or registration valid ON DATE AND TIME COMPLAINT WAS ISSUED, (b) \$257.00 if no proof.

++ 28-907A CHILD RESTRAINT: \$187 fine (or) a diversion may be available on first offense. Contact the Court for details.

+++RED LIGHT VIOLATIONS:

IMPORTANT NOTICE: If you have been cited for 28-645A3A, or are under age 18 (First Offense) and are found responsible for a moving violation by the court, you will be required to attend a traffic survival school (TSS) class by the Motor Vehicle Division (MVD) pursuant to the requirements of the Arizona Revised Statutes. If you are eligible for Defensive Driving Class and complete a class, the violation will be dismissed and you will not be subject to the requirement to attend a TSS class by MVD.

READ

Please read page 1 and choose your option. **Do not** call the court unless the information you require is not listed herein.



Information Card

For Violations not listed, you must appear in court in person.

OPTION ONE

Attend a Defensive Driving Program. If you qualify, the following information applies to only one eligible charge. When you complete the course, you have no fine to pay, you do not have to appear in Court and no points will be placed on your driving record. See **Instructions for attending defensive driving class** on page two. (Commercial license not eligible.)

OPTION TWO

Admit the offense(s) on the ticket in three different ways. (a) Follow the INSTRUCTIONS FOR PAYING THE FINE BY MAIL on page 3; (b) pay the fine at the service counter of the Court between 8:00am and 4:00pm Monday through Friday (excluding holidays); or (c) appear in court on your court date.

OPTION THREE

Deny the offense on the ticket and request a hearing date in person or by mail. To deny the offense by mail, follow the instructions TO DENY THE OFFENSE AND REQUEST A HEARING on page 4.

NOTICE

If you fail to complete one of the three options above on or before the court date shown on a civil traffic ticket, the court will enter a default judgment against you. A civil sanction will be imposed, if you are charged with a criminal offense, and fail to appear, your license may be suspended and you may be arrested.

CAN'T PAY THE FINE IN FULL?

A payment schedule may be arranged. Follow the instructions on page 3 paragraph 9.
