Violations marked with a single asterisk (\*) are eligible for the Defensive Driving Class. You are **NOT** eligible if you have a commercial driver's license **AND** were operating a commercial vehicle at the time cited.

For violations not listed here, appear in court in person.

**\*\*28-2532A VEHICLE REGISTRATION:** (a) \$211.00 plus current or renewed registration; or (b) \$692.00 if registration not renewed; or (c) no fine if the defendant was an operator but not the owner of the motor vehicle, trailer or semitrailer. Show proof to the court.

**\*\*\*28-2354C LICENSE PLATE OBSTRUCTION:** First offense: \$174.00; Second Offense: \$302.00

**\*\*\*\* 28-4135A-C VEHICLE INSURANCE:** A conviction of ARS 28-4135 (No Proof of Insurance) requires a mandatory fine and suspension of your license and registration. If you produce to the Court proof of insurance in effect at the time of violation, the charge will be dismissed. If you did not have insurance on the violation date, the mandatory fine may be reduced and the elimination of suspension may occur if (1) you do not have prior convictions for no insurance (2) you provide the Court proof that you purchased a six-month insurance policy; and (3) you provide a copy your driving record from the Motor Vehicle Department or [www.servicearizona.com](http://www.servicearizona.com). If you did not have insurance on the date of violation, please bring your proof of insurance and a copy of your driving record from the Motor Vehicle Department with you to Court.

**\*\*\*\*\*28-4139A SUSPENDED REGISTRATION (PLATE):** (a) \$380.00 if reinstated vehicle registration and MVD receipt shown to court; or (b) \$617.00 if registration not reinstated; or (c) show proof from MVD to Court that suspension was an MVD error for dismissal of the charge.

**+ 28-3169A, 28-2158 LICENSE OR REGISTRATION NOT IN POSSESSION:** (a) Charge will be dismissed with proof of driver license or registration valid ON DATE AND TIME COMPLAINT WAS ISSUED, or (b) \$237.00 if no proof.

**++ 28-907A CHILD RESTRAINT SEAT:** First offense: Mail receipt proving purchase of child seat before your court date and there will be no fine.

**+++RED LIGHT VIOLATIONS: IMPORTANT NOTICE:** If you have been cited for 28-645A3A, or are under age 18 (First Offense) and are found responsible at trial, you will be required to attend a traffic survival school (TSS) by the Motor Vehicle Division (MVD). If you are eligible for Defensive Driving Class and complete the class, the violation will be dismissed and you will not be subject to the requirement to attend TSS class by MVD.

**++++28-1177A & B OHV DECAL:** No fine with proof of current OHV decal.

**++++EQUIPMENT VIOLATIONS:** First offense: Mail receipt proving compliance before your court date and there will be no fine.

**COMMERCIAL VEHICLE VIOLATIONS:** CDL Drivers must call 928-536-4141 on or before your court date, or you must appear in person or through an attorney. This number is for CDL Drivers only.

## Information Card

### OPTION ONE

Attend a Defensive Driving Program. If you qualify, the following information applies to **only one** eligible charge. When you complete the course, you do not have to pay the fine for that charge, you do not have to appear in Court, and no points will be placed on your driving record. See **Instructions for attending defensive driving class** on page 2. CDL drivers driving commercial vehicles are not eligible.

### OPTION TWO

Admit the offense(s) on the ticket in three different ways. (a) Follow the **INSTRUCTIONS FOR PAYING THE FINE BY MAIL** on page 3; (b) pay the fine at the service counter of the Court between 8:00am and 4:30pm Monday through Friday (excluding holidays); or (c) appear in court on your court date.

### OPTION THREE

Deny the offense(s) on the ticket and request a hearing date in person or by mail. To deny the offense by mail, follow the instructions to **DENY THE OFFENSE AND REQUEST A HEARING** on page 4.

### NOTICE

If you fail to complete one of the three options above **on or before** the court date shown on a civil traffic ticket, the court will enter a default judgment against you. A civil sanction will be imposed, and your driver's license may remain suspended until the civil sanction and late fees are paid to the court. If you are charged with a criminal offense, and fail to appear, your license may be suspended and you may be arrested.

### CAN'T PAY THE FINE IN FULL?

A payment schedule may be arranged. Follow the instructions on page 3, paragraph 9.

## Option One

### ATTEND DEFENSIVE DRIVING CLASS (DDC)

You are eligible for the Defensive Driving Class if:

- You have not attended within the last 12 months (violation date to violation date); and
- You do not contest your ticket; and
- You were cited for a moving civil violation not involving serious injury or death; and
- An asterisk (\*) is listed next to the violation on page 5.

**CDL DRIVERS** – If you received a civil traffic moving violation **WHILE DRIVING A NON-COMMERCIAL MOTOR VEHICLE** you may attend Defensive Driving School.

### INSTRUCTIONS FOR ATTENDING DEFENSIVE DRIVING CLASS (DDC)

- If you choose to attend this course:  
You must complete the course at least **SEVEN DAYS PRIOR TO YOUR ARRAIGNMENT DATE**. If you need a 30-day extension **YOU MUST CALL THE COURT PRIOR TO YOUR COURT DATE**. Only one extension will be given. If you fail to complete the class you will be required to pay the fine and the \$20 late fee in full.
- You may only attend an Arizona Supreme Court certified school. To register, call 1-888-334-5565 or visit the website: [www.azdrive.com](http://www.azdrive.com). To attend an **Out-of-State** school, you **must** register with an Arizona school at the number or website above.
- Please have your ticket with you when you register for the class.
- Follow the instructions provided by the Defensive Driving School. Most schools will require you to provide your driver license and traffic citation.
  - In-person courses require a money order for the full amount of the course on the day you attend the class.
  - Online courses require debit or credit card payment for the full amount of the course prior to allowing you to access the online course.

- Mail your payment, with this form, payable to **SNOWFLAKE JUSTICE COURT** to the address shown on page 4. **DO NOT SEND CASH OR FOREIGN CURRENCY**. You can also pay by credit or debit card (a processing fee will apply for all charge card transactions) by calling 1-928-499-3032 or online at [www.snowflaketix.com](http://www.snowflaketix.com).
- Payment in full must be **received or postmarked** before your court date, or extra fees must be added.
- If you pay late, a \$20 late fee must be added.
- If you are unable to pay the amount in full, you must arrange a payment schedule prior to your court date by calling a Court Collections Officer at 928-536-4141. A time-payment fee of \$20 must be added to all payment plans.

## Option Three

### TO DENY THE OFFENSE AND REQUEST A HEARING

The following must be received before the court date shown on the bottom of your ticket. This is your **ARRAIGNMENT DATE, NOT YOUR HEARING DATE**.

- Read and sign the following statement:

*I hereby plead not responsible and request a hearing, and give up the right to attend a Defensive Driving Class.*

You will then be notified by mail of your trial date. **Setting a hearing will result in the loss of the privilege to attend defensive driving class. Failure to appear at your scheduled hearing date will result in default judgment entered against you for the amount of the fine plus collection costs and fees AND suspension of your driving privileges.**

### NOTICE TO JUVENILES

1) Juveniles charged with civil traffic violation(s) only, may choose any option on page one. 2) Juveniles charged with criminal traffic violation or misdemeanor offenses must appear in court in person with a parent/guardian; 3) Juveniles who admit to, or are found responsible for, a moving traffic violation are subject to separate administrative action by the Motor Vehicle Division which may include attendance at traffic survival school (TSS) or suspension of driving privileges
